## 1. INTRODUCTION:

Konkan Railway Corporation Limited (KRCL) invites ONLINE applications for various department posts. The following candidates are eligible to apply:

- (i) Land loser candidates: Candidates whose land has been acquired for the KRCL project, irrespective of the percentage of land lost; such persons can be land losers themselves, their spouse (wife/husband), son, daughter, grandson, or granddaughter only.
- (ii) Other than land loser candidates: Candidates who are domiciled in Maharashtra, Goa, or Karnataka and have valid employment exchange cards registered with the Employment Exchange along the Konkan Railway route within the jurisdiction of Konkan Railway Corporation Ltd. (Raigad, Sindhudurg, and Ratnagiri Districts of Maharashtra, Goa and Uttara Kannada, Udupi and Dakshina Kannada/South Kannada Districts of Karnataka)
- (iii) Other than land loser candidates: Candidates who are domiciled in Maharashtra, Goa, or Karnataka.
- (iv) KRCL employees: KRCL employees who have completed at least three years of regular service in KRCL.

Three separate lists/panels will be prepared as follows:

- a) Land loser candidates
- b) Candidates registered in the Employment Exchanges along the KR route,
- c) Candidates domiciled in Maharashtra, Goa, or Karnataka besides the ones mentioned in a) and b) above plus eligible KRCL employees.

Candidates must declare their status at the time of application to avail of the above preferences. Land-loser candidates will be given priority for appointment. The second and third panels will be operated only after exhausting the panel of eligible land losers, depending upon the shortfall in the vacancies notified.

### Note:

**(a) As per the KRCL policy, recruitment in Erstwhile Group-D posts is limited to Land loser candidates only.**

(b) Serving KRCL employees are also eligible to apply subject to fulfilling the notification's terms and conditions, i.e., age, educational qualification, reservation, etc. After completing the online application, such employees should inform their immediate supervisor/controlling officer about their application. The selection of serving employees against this notification shall be subject to D&AR and Vigilance clearance.

The number of posts indicated above is provisional and may vary as per KRCL's requirements. Accordingly, KRCL will publish updated vacancy positions again on its website, indicating the revised vacancies, if any.

This notification provides for Vertical Reservation for Scheduled Caste (SC), Scheduled Tribe (ST), Other Backward Class-Non-Creamy Layer (OBC-NCL), Economically Weaker Section (EWS), and Horizontal Reservation for Ex-Servicemen (Ex. SM) and Persons with Benchmark Disabilities (PwBD).

**NOTE: EBC & EWS are different categories. EBC candidates are not entitled to any job reservation.**

Any unfilled vacancies of Ex-Servicemen (Ex. SM) and Economically Weaker Section (EWS) shall not be carried forward. The notification provides for horizontal reservation for Ex-Servicemen (Ex. SM) and Persons with Benchmark Disabilities (PwBD), irrespective of their community, wherever applicable and admissible.

**5. ELIGIBILITY CRITERIA:**

**5.1 AGE LIMIT** - 18 to 36 years.

The lower age limit is standard for all the notified posts. The upper age limit has been increased from 33 to 36 to provide relief to many candidates who may have exceeded the age limit due to the COVID-19 pandemic. The age shall be reckoned as on 01/08/2024.

**5.2** The relaxation in the upper age limit for the following categories/communities in the table below is applicable, subject to the submission of requisite certificates at the time of DV. This age relaxation is over and above the three-year age relaxation mentioned above.

- a. Candidates who wish to be considered against reserved vacancies or seek age relaxation must submit the requisite/relevant certificate in original from the Competent Authority in the prescribed format at the time of DV. Otherwise, their claim for SC/ST/OBC-NCL/ExSM/PwBD/EWS status will not be considered, and their candidature/applications will be considered under the General (UR) category if otherwise eligible. The certificates should be in the format annexed. Certificates submitted in any format other than those prescribed in this notification will not be accepted.
- b. Service personnel likely to be discharged from military service on or before 06/10/2025 are eligible to apply against this employment notice as Ex-Servicemen.
- c. Candidates eligible for age relaxation on more than one ground will benefit from the category with the maximum relaxation and will **not get the cumulative benefit.**
- d. SC, ST & OBC (NCL) candidates applying against UR vacancies will not get any age relaxation.
- e. PwBD candidates applying against UR vacancies will be allowed age relaxation applicable only for PwBD (UR), subject to suitability conditions.

**6. LAND LOSER CANDIDATES:**

A Land loser candidate is defined as a person who has lost his land for the KRCL project between Roha (Maharashtra) and Thokur (Karnataka) on the KRCL route, i.e., whose land was acquired for the Konkan Railway Project, irrespective of the



percentage of land lost. Such person himself/herself, his/her spouse (wife/husband), son, daughter, grandson, or granddaughter only are eligible.

As per the above definition, even the daughters/granddaughters/grandsons from the maternal side of the land loser are also eligible to apply as a land loser candidate.

KRCL has a policy of giving recruitment to ONLY one member per acquisition whose land has been acquired by KRCL (GEN & OBC-NCL). However, this condition does not apply to SC/ST Candidates. (Candidates should read the amended Recruitment Policy of KRCL dated 16/03/2018, 29/08/2019 and 02/09/2020, which is available on KRCL website [www.konkanrailway.com](http://www.konkanrailway.com) → Departments → Personnel → Recruitment Policy).

Land loser candidates, other than SC/ST, whose relative/joint owner of the same land survey number has already been recruited in KRCL, cannot apply as land loser candidates for the same land acquisition. However, they can apply as candidates registered in the Employment Exchanges along the KR route or as candidates domiciled in Maharashtra, Goa, or Karnataka. In such cases, they will not be eligible for the land loser benefits.

#### 6.1 PREFERENCE IN RECRUITMENT:

Candidates securing the minimum qualifying marks prescribed for the posts shall be given preference in recruitment in the following order:

- 1. Land loser candidates:** Eligible land loser candidates will be given first preference for recruitment. The land loser candidates have been defined in terms of this office letter no.CO-13033/1/2018-Pers dated 29/08/2019 (also mentioned in para 6 of this notification).
- 2. Candidates registered in Employment Exchanges along KR route:** Second preference for recruitment will be given to other than land losers who are domiciled in Maharashtra, Goa, Karnataka and are registered in the Employment Exchange along Konkan Railway route within the jurisdiction of Konkan Railway Corporation Ltd. (Raigad, Sindhudurg and Ratnagiri Districts of Maharashtra, Goa State, Uttara Kannada, Udupi and Dakshina Kannada/South Kannada Districts of Karnataka).
- 3. Domicile of Maharashtra, GOA, Karnataka, and KRCL employees:** Third preference for recruitment will be given to non-land losers domiciled in Maharashtra, Goa, Karnataka, and KRCL employees.

Note:

a) Three separate lists/panels will be prepared for land loser candidates, candidates registered in the Employment Exchanges along the KR route, and

non-land land loser candidates domiciled in Maharashtra, Goa, Karnataka, plus KRCL employees.

b) To avail of the above preferences, the candidate must declare his/her status at the time of application.

## **7. VERTICAL RESERVATION:**

**7.1** This notification provides for vertical reservation for Economically Weaker Sections (EWS), Scheduled Caste (SC), Scheduled Tribe (ST), and Other Backward Class (Non-Creamy Layer) (OBC-NCL), wherever applicable and admissible under extant rules. Only those communities recognized by the Government of India as SC, ST, and OBC (Non-Creamy Layer) are eligible for reservation.

**NOTE: EBC & EWS are different categories. EBC candidates are not entitled to any job reservation.**

**7.2** All candidates, irrespective of community, will be considered against general, i.e., unreserved (UR) vacancies (subject to fulfillment of eligibility conditions required for UR). However, vacancies reserved for specific groups (viz., SC, ST, OBC(NCL) & EWS) will be filled only by candidates from that community/category.

**7.3** Hence, EWS, SC, ST, and OBC-NCL candidates who fulfill the requisite educational and technical qualifications can also apply against UR vacancies, for which they will have to compete as general (unreserved) candidates without any relaxation/concession in age, educational qualification, marks, etc. at any stage of examination. In any case, candidates are advised to indicate their actual community in the application.

**7.4** For availing reservation, EWS, SC, ST & OBC-NCL candidates should furnish the necessary certificates (in original) during DV. The certificates should be issued by competent authorities as per the formats given at Annexure-IV (for SC & ST candidates), Annexure-V (for OBC-NCL candidates) and Annexure-IX (for EWS candidates).

**7.5** The caste certificate for OBC-NCL candidates should specifically mention that "This is also to certify that he/she does NOT belong to the persons/sections (Creamy Layer) mentioned in Column 3 of the Schedule to the Government of India, Department of Personnel & Training OM No. 36012/22/93-Estt.(SCT) dated 08/09/93 and modified vide GOI DOPT OM No. 36033/1/2013-Estt.(Res.) dated 13/09/2017\* (\*further revision if any, received till the closing date of submission of applications against this notification).

**7.6** A person seeking an appointment based on the reservation to OBCs must ensure that he possesses the caste/community certificate and does not fall into a creamy layer on the closing date for application submission. During DV, such candidates should produce their original OBC-NCL certificate (in prescribed format), valid as on the closing date for submission of application, AND also a self-declaration (in the format given in Annexure-VI) stating that they "do not belong to creamy layer". Or else, their claim for reservation (as OBC-NCL) will not be accepted, and instead, they may be treated only as UR candidates subject to fulfillment of all eligibility conditions.

**7.7 IMPORTANT:** Community/category status as of the closing date for submission of applications against this notification shall only be considered for reservation and related benefits as per eligibility. Any change in this status thereafter shall not be entertained.

**7.8 EWS (Economically Weaker Section) Reservation:**

Candidates not covered under the scheme of reservation for SC/ST/OBC-NCL and whose family gross annual income is below Rs. 8 Lakh (Rupees Eight Lakh) are to be identified as EWS for the benefit of reservation for EWS. The income shall also include income from all sources, i.e., salary, agriculture, business, profession, etc., for the financial year prior to the year of application. Also, candidates whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of family income:

**7.8.1:** 5 acres of agricultural land and above;

**7.8.2:** Residential flat of 1000 sq. ft. and above;

**7.8.3:** Residential plot of 100 sq. yards and above in notified municipalities;

**7.8.4:** Residential plot of 200 sq. yards and above in areas other than the notified municipalities.

The property held by a family in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status. The term Family for this purpose will include the person who seeks the benefit of reservation, their parents and siblings below the age of 18, and their spouse and children below the age of 18. The benefit of reservation under EWS can be availed upon producing an Income and Asset Certificate issued by a Competent Authority. The Income and Asset Certificate issued by any one of the following authorities in the prescribed format as given in Annexure-IX shall only be accepted as the candidate's claim as belonging to EWS:

A) District Magistrate / Additional District Magistrate / Collector / Deputy Commissioner / Additional Deputy Commissioner / 1st Class Stipendiary Magistrate / Sub-Divisional Magistrate / Taluka Magistrate / Executive Magistrate/ Adnl Assistant Commissioner;

B) Chief Presidency Magistrate/Additional Chief Presidency Magistrate / Presidency Magistrate;

C) Revenue Officer not below the rank of Tehsildar;

D) Sub-Divisional Officer of the area where the candidate and/or his family normally resides.

The candidates applying against the vacancies reserved for EWS must possess an Income and Asset Certificate as of the closing date of submission of applications against this notification. Accordingly, they have to fill out the certificate number, date of issue of the certificate, issuing authority, district, and state of issue in the ONLINE application. Further, these candidates must also produce valid Income and Asset Certificate during document verification. In case of non-compliance to these stipulations, their claim for reserved status under EWS will not be entertained. The candidature/application of such candidates, if fulfilling all the eligibility conditions for the General (UR) category, will be considered only under General (UR) vacancies.

## **8. HORIZONTAL RESERVATION:**

**8.1:** This notification also provides horizontal reservation for Ex-Servicemen (Ex. SM) and PwBD, irrespective of their social community;

**8.2:** The vacancies shown in the Vacancy Table also include those reserved for Ex.SM and PwBD;

**8.3:** Ex.SM candidates can also apply against unreserved vacancies of any post(s) not exclusively earmarked for them. They will be eligible for age relaxation and fee exemption while applying for these posts.

**8.4:** Similarly, PwBD candidates can also apply against unreserved vacancies of any post(s) not exclusively earmarked for them, but the post must be indicated as suitable for their disability. They will be eligible for age relaxation and fee exemption while applying for these posts.

**8.5:** If vacancies reserved for PwBD cannot be filled due to the non-availability of suitable candidates under that category of disability or for any other reason, they will not be filled and will be carried forward as backlog vacancies.

## **9. EX-SERVICEMEN:**

**9.1:** The term Ex-Serviceman means a person who has served in any rank (whether as a combatant or a non-combatant) in the regular Army, Navy, or Air Force of the Indian Union but does not include a person who has served in the Defence Security Corps., the General Reserve Engineering Force, the Lok Sahayak Sena, and the Para Military Forces, and -

- a) who either has been retired or relieved or discharged from such service, whether at his own request or being relieved by the employer after earning his or her pension; (or)
- b) who has been relieved from such service on medical grounds attributable to military service or circumstances beyond his control and awarded medical or other disability pension; (or)
- c) who has been released from such service as a result of a reduction in establishment; (or)
- d) who has been released from such service after completing the specific period of engagement, otherwise than on his own request, or by way of dismissal, or discharge on account of misconduct or inefficiency and has been given a gratuity; and includes personnel of the Territorial Army, namely, pension holders for continuous embodied service or broken spells of qualifying service; (or)
- e) Personnel of the Army Postal Service who are part of the Regular Army and retired from the Army Postal Service without reversion to their parent service with pension or are released from the Army Postal Service on medical grounds attributable to or aggravated by military service or circumstances beyond their control and awarded medical or other disability pension; (or)
- f) Personnel who were on deputation in the Army Postal Service for more than six months prior to 14th April 1987; (or)
- g) Gallantry award winners of the Armed forces, including personnel of the Territorial Army; (or)
- h) Ex-recruits boarded out or relieved on medical grounds and granted medical disability pension w.e.f. 01.02.2006.

**9.2:** Persons serving in the Armed Forces of the Union, who on retirement from service would come under the category of Ex-Servicemen are eligible to apply for re-employment one year before the completion of the specific terms of engagement and avail themselves of all concessions available to Ex-Servicemen but such persons shall not be permitted to leave the uniform until they complete the specific terms of engagement in the Armed Forces of the Union.

**9.3:** Accordingly, such serving Defence personnel to be released within one year (i.e., on or before 06/10/2025) of the closing date of submission of applications against this notification can also apply, both for vacancies earmarked for Ex-Servicemen and for posts not reserved for them. However, they should possess the prescribed Educational Qualification as of the closing date of submitting applications for this notification, i.e., 06/10/2024.

**9.4:** Ex-Servicemen candidates who have already secured civil employment under the Central Government in Group 'C' & erstwhile Group 'D' (including PSUs, Autonomous Bodies/Statutory Bodies, Nationalized Banks, etc.) after availing of

the benefits given to Ex-Servicemen will be permitted only the benefit of age relaxation as prescribed for Ex-Servicemen for securing another civil employment in a higher grade or cadre in Group 'C'/ erstwhile Group 'D' under Central Government. Such candidates will not be considered for the vacancies reserved for ex-servicemen in central government jobs.

**9.5:** If an Ex-Serviceman applies for various vacancies before joining any Civil employment, they can avail themselves the benefit of reservation as Ex-Serviceman for any subsequent employment, subject to the condition that an Ex-Serviceman as soon as he joins any Civil employment, should give self-declaration/undertaking to the concerned employer about the details of application against this notification. The acknowledged copy of this declaration and NOC from the civil employer should be produced during DV, failing which their candidature shall be canceled. Further, this benefit would be available only regarding vacancies filled on direct recruitment and wherever reservation is applicable to the Ex-Servicemen.

#### **10. PERSONS WITH BENCHMARK DISABILITIES (PwBD):**

Categories of disabilities (subject to a minimum of 40% disability) for this recruitment are given below:

HI - Hearing Impairment(Deaf, Hard of Hearing)

LD - Locomotor Disability (One Leg, Both Legs, Dwarfism, Acid Attack Victim, Leprosy Cured)

MD - Multiple Disability (multiple disabilities from amongst persons under clauses (a) to (c) including deaf-blindness in the post identified explicitly for each disability - subject to the condition that each one of the disabilities should be at least 40% or more)

**NOTE:** Candidates may please refer to the GOI website <https://depwd.gov.in/acts/> and check the relevant portions of the Rights of Persons with Disabilities Act, 2016, for further details.

**10.1:** The suitability or otherwise of a post for PwBD has been indicated in the Post Parameters Table (Annexure-A) against each post under the column "Suitability for Persons with Benchmark Disabilities" with details of a specified sub-category of disability.

**10.2:** PwBD candidates must be careful to apply only for posts clearly mentioned as suitable for their benchmark disability or specified sub-category of disability to avoid disqualification.

**10.3:** DEGREE OF DISABILITY FOR RELAXATION AND COMPETENT AUTHORITY FOR ISSUE OF DISABILITY CERTIFICATE: Only such persons

would be eligible for a relaxation of conditions/reservation in a respective community in services/posts who suffer from not less than 40 percent of relevant disability. A person who wants to avail the benefit of relaxation will have to submit a Disability Certificate issued by a Competent Authority, as per proforma at Annexure-V(A), V(B) & V(C) {Form V, VI or VII as applicable as prescribed in Rule 18(1) of the Gazette Notification (Extraordinary) dated 15th June 2017 of the Rights of Persons with Disabilities Rules, 2017} at the time of DV.

**10.4: Assistance of Scribe:** Candidates affected by Cerebral Palsy/candidates with one arm/candidates with muscular dystrophy / Intellectual disability (Autism, specific learning disability, and mental illness) can avail the assistance of a SCRIBE for writing answers on their behalf. Candidates must indicate this in their ONLINE application to engage a scribe. The engagement of a scribe will be subject to the following conditions:

**10.4.1:** A PwBD candidate eligible for a scribe must arrange the scribe on their own. KRCL shall not provide a scribe.

**10.4.2:** A separate e-call letter will be issued to the scribe accompanying the candidate.

**10.4.3:** The candidate shall be responsible for any misconduct of the scribe during the examination.

**10.4.4:** The scribe should not be a candidate in this notification.

**10.4.5:** The same scribe should not be engaged by more than one candidate. Both - the scribe and the candidate - shall give a declaration to this effect. Any violation, if detected at any stage, will result in disqualification of both the candidate and the scribe.

**10.4.6:** Candidates requesting a scribe must provide additional details of their Scribe [as per Annexure-V(D)] in the ONLINE application so that KRCL can issue necessary e-call letters.

**10.4.7:** During the CBT, the e-call letters shall be signed by both candidate and scribe. A change of scribe is not permissible at the CBT venue, and hence, it is the candidate's responsibility to ensure the availability of the same scribe. However, under exceptional circumstances, a change may be allowed, duly recording reasons and filling out the relevant details, including a photograph of the changed scribe.

**10.4.8:** Candidates availing the assistance of a scribe shall be eligible for compensatory time of 20 minutes for every hour of CBT.

**10.4.9:** All one-eyed candidates and candidates whose visual degree of disability is less than 40% shall not be eligible for engaging a scribe.

**10.5:** Selected PwBD candidates will be subjected to a medical examination by Konkan Railway Medical Authorities after their DV. Only those conforming to the prescribed Medical Standards will be eligible for empanelment (against posts identified as suitable for their disability).

## 11. EDUCATIONAL QUALIFICATION:

- (a) Please see the Post Parameters Table (Annexure-A) for the prescribed qualifications for each post.
- (b) Candidates appearing and awaiting final examination results of the prescribed educational/technical qualification can also apply. However, they will be required to produce the requisite certificate of having acquired the educational qualification at the time of document verification, failing which their candidature will be rejected.
- (c) Diploma/Degree in Engineering will not be accepted unless otherwise specified, instead of Course Completed Act Apprentices/ITI for the Technicians in Pay Level-2 post. Graduate Act apprentice will not be accepted in place of Course Completed Act Apprenticeship (CCAA).

## 12. HOW TO APPLY:

### Preference of Post:

**Multiple posts in various PML, their details, and other requirements have been indicated in para (2) & (3) of this notification. Candidates can apply for multiple posts based on their educational qualifications. Candidates are required to indicate their post-wise preference very carefully. Once exercised in the ONLINE application, options shall be final, and no request for change shall be entertained. Therefore, candidates are advised to exercise the option for post(s) carefully. KRCL will allot only one post to the selected candidate as per the preference of the candidate, subject to merit, vacancy position, and qualifying the various stages of the selection process.**

**Candidates are permitted to apply for only one post from Technician-III/Electrical and Technician-III/Mechanical.**

**Note: Any request by candidates selected for a specific post as per their preference for allotment of a post lower in the preference shall not be entertained.**

- a) **CANDIDATES ARE ADVISED TO VISIT ONLY THE OFFICIAL WEBSITES OF KRCL, i.e., [www.konkanrailway.com](http://www.konkanrailway.com) AND BE VERY CAUTIOUS ABOUT FAKE WEBSITES AND JOB RACKETEERS.**
- b) Candidates should ensure they possess/fulfill all eligibility conditions prescribed for the post as of the closing date for applying.
- c) Candidates who possess/fulfill all eligibility conditions prescribed for the post as of the closing date for applying may apply for one or more posts in a single application in the order of their preference for which candidate is



eligible and interested in applying. Payment of the prescribed examination fee for each CBT Examination Group selected by the candidates as indicated under Para (3) of this notification is to be made by the candidates at the time of filling out an ONLINE application. Any attempt by a candidate to register more than once against this notification shall result in the rejection of all registrations, disqualification, and debarment from the selection process of this notification.

Candidates are advised to refer to paras. 18 and 19 of this notification for details regarding the examination fee and mode of payment.

- d) Eligibility of the candidates to be called for CBT will be considered only on the strength of the information furnished in the ONLINE Application. If at any stage of recruitment or thereafter, it is found that any information furnished by the candidate in his/her application is false/incorrect, or the candidate has suppressed any relevant information, or the candidate does not satisfy the eligibility criteria for the post, his/her candidature will be rejected immediately.**
- e) Candidates are advised to read all the information and instructions detailed in the notification thoroughly before starting to fill out the application by clicking the link on the official website of KRCL. It is essential that the candidate understands all the information in the notification correctly to prevent any mistakes while filling out the application.
- f) Candidates should have their own mobile number and valid and active personal email ID and keep these active for the entire duration of recruitment. KRCL shall send all recruitment-related communications only through SMS and email until the recruitment process is complete. KRCL will not entertain any request for a change of mobile number and e-mail address at any stage.
- g) Candidates should enter their Name, Father's Name, and Date of Birth as recorded in the Matriculation/SSLC/High School Examination Certificate or an equivalent certificate ONLY.
- h) In cases of name change, candidates should indicate their changed name only in the ONLINE application. However, other details should match with the Matriculation or Equivalent certificate. The date of such change (or) application for such change should be prior to the date of submission of the ONLINE application. The candidate must submit the Gazette Notification or any other legal document, as applicable, at the time of DV.

- i) To ensure speedy filling up of the ONLINE application by the candidates, they should keep ready scanned copies of following mandatory documents before filling out the application:
- A recent, clear-coloured passport-size photograph (against a plain white background) in JPEG image (size 30 to 70 KB)-without dark glasses and/or cap;  
**Note:** Candidates must have at least 12 (twelve) copies of the same photograph for future use during the recruitment process.
  - Scanned JPEG image of candidate's signature in running handwriting (size 30 to 70 KB);
  - SC/ST certificate (only for candidates requesting free passes for train travel) in PDF format (up to 500KB);
  - PwBD candidates should also upload a passport-sized photograph as per the above specifications only (not the full-body photograph used in the disability certificate).
  - Scribe (applicable to the eligible PwBD candidates only): provide details of Scribe duly uploading their passport-size photograph (against a plain white background) of the Scribe in JPEG image (size 30 to 70 KB) – without wearing dark glasses and/or cap. Furnishing of information of Scribe is mandatory. Change of Scribe at the examination venue is generally not permitted. However, under exceptional circumstances, the change may be allowed by duly recording reasons and filling in the relevant details, including a photograph of the Scribe.
- j) Candidates are further advised to visit KRCL's website frequently to get the latest information on the various stages of the recruitment process or any changes to this notification.
- k) The candidates are responsible for proving with valid documents that all the information they submitted in the ONLINE application is true.
- l) **Registration Process & Filling of Online Application:** The candidates shall first register their names by visiting the official website of KRCL, [www.konkanrailway.com](http://www.konkanrailway.com). A registration number will be generated upon successful registration. This registration number and password will be sent to the candidates via registered email and mobile number. Further, a link for making an application along with the registration number and password will be sent to the candidate's registered e-mail address. On activation of this link, the candidate will get access to the application form. **The link for registration and application submission will go live on 16/09/2024.**
- m) **Candidates must submit their Aadhaar Number when they register. Therefore, they are advised to update their Aadhaar details with UIDAI.**

- n) Candidates are advised to keep a printed copy of the ONLINE application with themselves. However, under no circumstances should candidates send a hard or soft copy of the application or any document to KRCL. The same should be produced only at the time of DV.
- o) Candidates are advised to note and preserve their Registration Number for further stages of the recruitment process and correspondence with KRCL.

**Candidates are advised to submit their ONLINE applications well before the closing date since there is a possibility of inability/failure to log on to the website due to heavy load on the internet or the website during the last few days.**

### **13. INVALID APPLICATIONS / REJECTIONS:**

Online applications are liable for rejection on the following grounds, amongst others:

- Invalid photos on account of Black and White photos, photos with a cap or wearing goggles/dark glasses, disfigured photos, small photos, full-body photos, photos having only one side view of the face, unrecognizable photos, photostat copies of the photos, group photos, online applications without photos, candidate signatures in capital letters, among others;
- Any other irregularities which are observed and considered invalid by KRCL.
- In case the application is rejected, candidates will be able to view their status ONLINE on the KRCL website along with the reason(s) for rejection(s), which is final and binding; no further correspondence shall be entertained on the subject. No refund of the examination fee will be made on account of the rejection of the application. SMS and e-mail alerts shall also be sent to the candidates using their registered mobile numbers and e-mail IDs, as indicated in their ONLINE application. Candidates will not be intimated by post.

- Candidates serving (including those undergoing induction training/probation) in any Central/State Government Department, including Railways or PSU, may apply directly to KRCL, duly informing their employer. #### **14. RECRUITMENT PROCESS:**

**14.1:** The recruitment process of Station Master (SM) and Assistant Loco Pilot(ALP) shall involve CBT, Computer-Based Aptitude Test/ OMR-based Aptitude Test, Document Verification, and Medical Examination. Candidates qualifying for the CBT shall be called for a Computer-Based Aptitude Test/OMR-based Aptitude Test eight times the number of posts notified in the SM/ALP category. However, this number may vary depending on the total number of vacancies. A merit list of candidates qualifying for the Computer-Based Aptitude Test/OMR-based Aptitude Test will be prepared by giving 70% weightage to CBT marks and 30% weightage to Aptitude test marks. DV will follow this.

**14.2:** The recruitment process for the posts of Senior Section Engineer (Civil), Senior Section Engineer (Electrical), Goods Train Manager (GTM), Commercial Supervisor, Technician-III/Mechanical, Technician-III/Electrical, and ESTM shall involve CBT followed by the Document Verification and Medical Examination.

**14.3:** The recruitment process for the Pointsman and Track Maintainer posts shall involve CBT followed by Document Verification, Physical Efficiency Test (PET), and Medical Examination.

Candidates qualifying the CBT will be called for document verification (DV) five times the number of vacancies notified. After that, candidates equal to three times the number of vacancies notified who qualify in CBT and DV will be called for PET. PET is qualifying in nature.

**The date, time, and venue for CBT and other additional activities as applicable shall decided by KRCL and intimated to the eligible candidates. Request for any modification in this regard shall not be entertained.**

**14.4: CBT:** The CBTs are tentatively scheduled for November 2024.

The CBT is screening in nature, and the standard of questions will generally be in conformity with the educational standards and/or minimum technical qualification prescribed for the post.

**Negative Marking: Incorrect answers in CBT will be marked negatively. One-third of the marks allotted for each question will be deducted for each wrong answer.**

**14.5: Banned Items:** Candidates carrying banned items like communication devices and Electronic gadgets (Mobile phones, Bluetooth devices, pen drives, laptops, calculators, smart watches), bangles, chains, bracelets, hearing aids, wallets/purses, metallic wears, etc., or any stationery items like pen/pencil shall not be allowed to appear during the examination. Any infringement/violation of this instruction shall lead to disqualification, legal action, and debarment from future examinations of KRCL.

Cloakroom arrangements for safekeeping belongings may not be available at the examination venues. Therefore, candidates are advised to refrain from bringing any valuables or banned items, including mobile phones, etc., to the examination venue. KRCL management shall not be responsible for the loss of any such item brought to the CBT venue.

#### **14.6: CBT- Qualifying Marks**

The minimum percentage of marks required for various categories to qualify for the next recruitment process shall be as follows:

1. The marks mentioned above are the minimum qualifying marks. If more than the required number of candidates are able to secure the minimum qualifying marks, then the cutoff may be more than the qualifying marks.
2. These percentage marks for eligibility may be reduced by 2% for PwBD candidates.

#### **14.7: CBT- Pattern and Syllabus**

**CBT Pattern:** The questions in CBT will be in Hindi and English for the posts of Senior Section Engineer/Civil, Senior Section Engineer/Electrical, Station Master,

Commercial Supervisor, Goods Train Manager, Technician/Mechanical, Technician/Electrical, ESTM, and Assistant Loco Pilot.

CBAT/OMR Based Aptitude Test for the posts of Station Master and Assistant Loco Pilot will be conducted in English and Hindi.

For the posts of Track Maintainer and Pointsman, the CBT will be in five languages (English, Hindi, Marathi, Konkani, and Kannada). The candidate must choose any one of these languages.

**Note: In case of any discrepancy between various versions, the English version will prevail.**

**14.12: OBJECTION AGAINST ANSWER KEY:**

After the CBT, a link shall be provided on the Konkan Railway website ([www.konkanrailway.com](http://www.konkanrailway.com)) to enable candidates who appeared in the CBT to view their question papers, responses, and answer keys. After viewing these details, objections, if any, regarding the questions, options, and keys published can be raised by the candidates, for which a schedule will be published on the KRCL website. Candidates can submit their objections online by paying fees of Rs. 59/- (Applicable fee of Rs. 50/- + GST @ 18%) + payment of gateway charges, if any, for each objection. If the objection is correct, the fee paid against such valid objections shall be refunded to the candidate, duly deducting bank charges as applicable. However, if the objection is incorrect, the candidate will forfeit the money.

**15. NORMALISATION OF MARKS:**

The examination may have to be conducted in multiple sessions in CBT and for CBAT / OMR Based Aptitude Tests. For these multisession papers, a suitable normalization is applied to account for any variation in the difficulty levels of the question papers across different sessions. The formula for calculating the normalized marks for the multi-session papers is detailed below :

Normalization mark of  $j^{\text{th}}$  candidate in  $i^{\text{th}}$  session  $\widehat{M}_{ij}$  is given by :

$M_{ij}$  : is the actual marks obtained by the  $j^{\text{th}}$  candidate in  $i^{\text{th}}$  session.

$\overline{M}_i^g$  : is the average marks of the top 0.1% of the candidates considering all sessions.

$M_q^g$  : is the sum of mean and standard deviation marks of the candidates in the paper considering all sessions.

$M_{ii}$  : is the average marks of the top 0.1% of the candidates in the  $i^{\text{th}}$  session or marks of topper if session strength is less than 1000.

$M_{iq}$  : is the sum of the mean marks and standard deviation of the  $i^{\text{th}}$  session.

## 16. PHYSICAL EFFICIENCY TEST:

The following criteria will be followed for the Physical Efficiency Test (PET) :

**Male:** Should be able to run a distance of 1000 meters in 4 minutes and 15 seconds in one chance.

**Female:** Should be able to run a distance of 400 meters in 3 minutes and 10 seconds in one chance.

## 17. MEDICAL STANDARDS FOR THE POSTS:

Candidates called for DV and found eligible must pass a requisite medical examination(s) before their final empanelment to the post extent of the vacancies notified. The candidate shall bear the expenses towards the medical examination. Visual Acuity Standard is one of the essential criteria of medical fitness for KRCL employees. The medical requirements against different medical standards for various categories are outlined below:

Candidates who have undergone Lasik surgery or any other surgical procedure to correct refractory error are not eligible for the post having Medical Standard of A-1, A-2, A-3, and B-1.

**Affidavit for “Minority Community Declaration”:** Minority candidates claiming waiver of examination fee will be required to furnish an affidavit (as per Annexure-VIII) on non-judicial stamp paper mentioning their minority community at the time of DV, failing which their candidature will be rejected.

**18.3:** Economically Backward Class (EBC) candidates are those whose annual family income is less than Rs. 50,000 and are eligible for concessional fee (as per para 15.0 above). For this, they should have :

- a) Valid Income Certificate on the date of application in the prescribed format (as per Annexure-VII) on the letterhead of the Issuing Authority. The following authorities are authorized to issue income certificates to identify economically backward classes:

- District magistrate or any other Revenue Officer up to the level of Tahsildar;
- Sitting Member of Parliament of Lok Sabha for persons of their Constituency;
- Sitting Member of Parliament of Rajya Sabha for persons of the district in which these MPs normally reside;
- Union Minister for any persons from anywhere in the country.

(OR)

- b) BPL Card or any other certificate issued by the Central Government under a recognized poverty alleviation programme

(OR)

All EBC candidates who seek concessional fees should fill in the relevant details of a valid EBC certificate/BPL card in the ONLINE application. The same must also be submitted in the original at the time of DV, failing which, their candidature will be rejected.

**NOTE: EBC and EWS are distinct categories, and EBC should not be confused with OBC or EWS. EBC candidates should know that they are entitled only to fee concession, not job reservation.**

#### **19. MODES OF PAYMENT OF FEE**

- ONLINE fee payment will only be accepted through Internet banking, debit/credit cards, or UPI. The candidate shall bear all applicable service charges.
- Candidates can pay the fee ONLINE only. There will be no option to pay the fee through any other mode.
- Applications received without a prescribed fee shall not be considered and will be summarily rejected. No representation against such rejection will be entertained.

#### **21. INSTRUCTION RELATED TO E-CALL LETTER :**

- a) SMS and email messages will be sent to all eligible candidates with details of the e-call letter. Eligible candidates can download the e-call letter from the

KRCL website about 10 days before the date of the CBT/CBAT or OMR Based Aptitude Test /DV (as applicable).

- b) Call letters will not be sent by post to candidates.

For all posts other than PML-1 posts:

- Candidates successfully qualifying the CBT (and CBAT or OMR Based Aptitude Test, wherever applicable) will be called for DV for the respective PML and post in the order of merit, equal to the number of posts.
- Preference shall be given to Land loser candidates.

  - m) NOC from a current employer with the date of appointment if the candidate is a serving employee (including those undergoing induction training/probation) in any Central/State Government Department, including Railways or PSU.
  - n) Original discharge certificate for Ex-serviceman. NOC from Serving Defence Personnel with probable date of discharge (if applicable)

- o) Gazette notification and/or any Legal document in case of a formal name change.

## **24. IMPORTANT INSTRUCTIONS**
