

# TRIPURA PUBLIC SERVICE COMMISSION AGARTALA

Advt. No. 07/2024

Online applications are invited from bonafide citizens of India for recruitment to the post of **General Duty Medical Officer**, Grade-IV of THS, Group-A (Gazetted) under Health & Family Welfare Department, Govt. of Tripura. In the scale of pay at Pay Matrix Level-14 of 2018. The total vacancy positions are given in the table below:-

The number of vacancy to be filled up is subject to increase or decrease following requisition of the Department.

## **Educational Qualifications:**

- (i) A medical qualification included in the First or Second schedule or Part-II of the Third schedule (other than Licentiate qualification) to the Indian Medical Council Act, 1956. Holders of Educational qualifications included in Part-II of the Third schedule should fulfill the conditions stipulated in Section 13(3) of the Indian Medical Council Act, 1956.
- (ii) Completion of internship and permanent Registration Certificate of any state Medical Council/Medical Council of India.

Age:- Up to 40 years as on 19.10.2024. Upper age limit is relaxable by 5(five) years in case of SC/ST/PH candidates and Government Servant. The Government employees belong to ST/SC/PH category shall not get this relaxation over and above the General relaxation of 5 years available to them.

- \* To apply for the aforementioned post, the applicant must have Permanent Resident Certificate of Tripura (PRTC). This is in pursuance of GA(P&T) Department Notification dated 07-07-2023.
- \*\* Candidates with Benchmark disabilities will be governed as per the Ministry of Social Justice & Empowerment, Government of India "THE PERSONS WITH DISABILITIES (EQUAL OPPORTUNITIES, PROTECTION OF RIGHT AND FULL PARTICIPATION) ACT, 1995" of the Department of Ministry of Law, Justice and Company Affairs Gazette publication dated 1st January, 1996 & subsequent amendments.

The last date of submission of online application is <u>19.10.2024</u>(upto 5.30 PM). The application(s) received after the closing date will not be entertained.

## **Selection Process:-**

- (a) As per service rule the Recruitment process will comprise of 02 (two) steps, viz -
  - (i) Written Examination: **85 marks** (MCQ type, OMR based) and time allotted will be **2 hours**.
  - (ii) Interview/ Viva: 15 marks.
- (b) For detailed syllabus of Written Examination (85 marks) & selection process please refer Health & Family Welfare Department Notification No. F.3(457)- HFW/2019 dated 26.10.2022 (Annexure-I).
- (c) 15 marks allotted for the Personality Test: The Test shall be to assess the personal qualities of the candidate's e.g. intellectual ability, social traits, interest in current affairs, critical power of judgment, variety and depth of interest, ability for leadership and moral integrity.
- (d) Candidates will be called for the Personality Test on the basis of the result of the Written Examination in the following ratio, subject to attaining of minimum qualifying marks:

Number of vacancies	Number of candidates to be called for Personality Test (Category wise)	
1(one)	5(five) candidates	
2(two)	8(eight) candidates	
3(three) and above	3(three)times the number of vacancies	

Candidate (s) scoring marks equal to that of the last candidate so selected for the Personality Test will also be called for Personality Test.

- (d) The final selection will be made in order of merit on the basis of the marks obtained by a candidate in the Written Examination (out of 85) and by adding the marks obtained in the Interview process (out of 15). If a candidate remains absent in the interview process his/her candidature will not be considered for final merit list.
- (e) In the list of recommendation, merit position of candidates securing equal marks will be finalized as per their seniority of age.

The same procedure is to be followed for preparing waiting List, if there be any.

Further provided that, in the list of recommendation, merit position of candidates securing equal marks in aggregate and also of the same age will be decided on the basis of percentage of marks obtained in the minimum educational qualification prescribed in Recruitment Rules/ Service Rules.

- (f) Ranks of the candidates are not prepared for the candidates beyond the recommendation list & wait list (if there be any).
- (g) Merit list will be prepared as per marks obtained by the candidates in category wise.
- (h) The candidates who will be found qualified in the Written Examination will be called to appear in the Interview cum Personality Test. In no case shall a candidate be called for interview cum personality test unless he/she appears in all the papers of the Written examination.

## Other Important information:

## 1. Online Application Portal:

- (a) Candidates will have to submit application through Online Application Portal only. The Commission will not entertain any hard copy application. Before submission of online application, read carefully the necessary instructions regarding filling up of online application.
- (b) Online Application Portal will be available on Commission's website from 10.09.2024 to 19.10.2024(5.30 PM). Before applying for the post, an applicant shall register his/her biodata particulars through One Time Profile Registration (OTPR) on the Commission's Website viz. <a href="https://tpsconline.in">https://tpsconline.in</a> or through the link provided in <a href="https://tpsc.tripura.gov.in">https://tpsc.tripura.gov.in</a> Once applicant registers his/her particulars, a User ID is generated and sent to his/her registered mobile number and email ID. Applicants need to apply for the post using the OTPR User ID through Commission's website.
- (c) Applicants should avoid submitting multiple applications. However, if due to any unavoidable circumstances, any applicant submits multiple applications then he/she must ensure that the application with latest Receipt Number is complete in all respects.
- (d) In case of multiple applications, the application with latest Receipt Number shall only be entertained by the Commission and fee paid against one Receipt Number shall not be adjusted against any other Receipt Number.
- 2. (a) With their respective application candidates are not required to upload/submit any certificate/document in support of their claims.
- (b) Applicants must be in possession of the prescribed minimum qualification(s) and others for the post on the closing date for submission of application as mentioned in the advertisement. Their admission at all the stages of examination for which they are admitted for the Written Examination will be purely provisional, subject to their satisfying the prescribed eligibility conditions. Mere issue of admission certificate to the candidate will not imply that his/her candidature has been finally cleared by the Commission.
- (c) After publication of result of Written Examination, successful candidates will be asked to submit self attested copies of the relevant documents i.e. Age proof certificate(birth certificate/Admit of Madhyamik), Educational Qualifications (Madhyamik onwards), MBBS all mark sheets along with pass certificate and internship completion certificate, Updated Permanent Registration Certificate of any State Medical Council or Medical Council of India, Scheduled Tribes/Scheduled Casts/PH/Ex-SM certificate (if any), PRTC etc. to the Reception Counter of TPSC or By post addressed to the Secretary, TPSC, Agartala, PIN-799001. Submission of such documents including through post will be allowed up to specified time along with forwarding letter falling which candidature will be treated as cancelled. The Commission will not entertain any documents thereafter.

(d) On scrutiny of documents if a candidate found ineligible as per terms and condition of the advertisement (including prescribed recruitment fees)his/ her candidature will be rejected. If the application is not routed through proper channel, at the day of interview candidates will have to submit 'no objection' certificate failing which his/ her candidature will not be considered for preparation of final merit list. In that no-objection certificate, it is to be clearly mentioned that your employer has 'No-objection' if you are considered for recruitment to the post for which you have applied for.

## (3) Rate of Recruitment Fees:

- (a) Rs. 400/-(Rupees four hundred) for General Candidates and Rs.350/-(Rupees three hundred & fifty) only for ST/SC/ BPL card holders/Physically Handicapped Candidates.
- (b) Recruitment fee so deposited, is non-refundable.
- (c) If a candidate submits incomplete application in respect of terms & condition of the Advertisement and without requisite recruitment fee, his/her candidature will be rejected.
- (4) Decision of the Commission as to the eligibility or otherwise of a candidate at any stage of the selection process shall be final.
- (5) Assessment and evaluation of the answer scripts done by the Commission shall be final and shall not be open to scrutiny by any external authority.
- (6) The Examination venue shall be closed 10 minutes before the Scheduled Commencement of Examination. No candidate shall be allowed entry into the examination venue after closure of entry. No functionary has any direction in this regard.
- (7) Candidates are instructed to visit the Commission's website for information regarding steps of recruitment process time to time.
- (8) Mobile Phone/Electronic Gadgets etc. are banned in the Campus of the Examination Premises/Interview Premises. Any Phone/Electronic Gadget found in possession of any candidate in the Examination Premises/Interview premises shall be confiscated forthwith and he/she may be debarred from appearing at the Examination/Interview and also for the Examination(s)/Interview to be conducted by the Commission in future Violation of such instruction will be dealt as per Law.

(9)Entry in the Examination hall/Interview Premises with Jacket, Coat, Pull over & this type of garments will not be allowed.

#### NOTIFICATION

In exercise of power conferred by the provisio to the Article 309 of the Constitution of India, the Governor, Tripura in consultation with the Tripura Public Service Commission is pleased to make the following rules further to amend the Tripura Health Service Rules, 1974, namely:-

- 1. Short Title and Commencement:
- These rules may be called the "Tripura Health Service (Nineteenth Amendment) Rules, 2022";
- They shall come into force from the date of publication in the Tripura Gazette.
- Amendment of First Schedule:

For First Schedule appended to the Tripura Health Service (17th Amendment) Rules, 2007, the following entries shall be substituted; namely-

"Tripura Health Service shall comprise the following cadre:-

- (i) General Duty Medical Officer Cadre(GDMO) (At least MBBS = 1131 posts)
- (ii) Specialist Cadre = 1039 posts.
  - (a) Super Specialist Sub Cadre (At least DM/MCh/DNB (equated to DM/MCh) etc. equivalent =88 posts).
  - (b) Specialist Sub Cadre (At least MD/MS/DNB/ PG Diploma recognized by National Medical Council (erstwhile MCI) for not less than 2(two) years equivalent =951 posts).

#### DIRECT RECRUITMENT

The selection to GDMO in Gr-IV of THS will be through written examination [85% exam + 15% viva) to be conducted by TPSC if the number of post exceed 10 (ten). If the number of post is less than 10 than selection will be conducted by TPSC on the basis of Academic Performance Index(API) and weightage shall be as follows;

- (a) MBBS -85%
- (b) Viva-15%

The syllabus and pattern shall be as follows:-

Total Marks: 100: Written Exam 85 + Interview 15

Question type: Multiple Choice Question, 85 questions all MCQ.
